## 3. NEW BUSINESS

#### 3.1 Undesignated Reserve Funds

- Staff reported out on the final undesignated reserve fund balance at the end of FY 21/22. All of those funds are currently allocated to a single object code at the County under one undesignated reserve fund account. Other reserve fund object codes are available to designate a portion of funds for specific purchases. There is a capital equipment replacement object code where funds could be moved to fund future capital replacement funds. County Auditors office can move the funds with a copy of the Board minutes approving the transfer.
- Discussion on CP Fire Contract Refund amounts that have been submitted. Allocate into a • specific undesignated reserve object code 349 Designation Other. Amount to transfer would be approx. \$40.831.00
- Discussion on capital replacement undesignated fund. Recommend fully funding the purchase of powerloads and gurneys. JPA looking into the payment plan option, but recommend fully funding the purchase and holding those funds in this account Object Code 323 Reserve Equipment Replacement. Amount to transfer would be approx. \$303,500.
- Staff recommended allocation undesignated reserve funds into the fixed asset budget to fund • the purchase of 2 vehicle remounts and upgraded cradlepoint devices. \$87,000 would be budgeted in object code 6040: Fixed Assets Equipment and \$350,000 would be budgeted in object code 6045: Fixed Asset Vehicles.
